

### **From M6 Junction 27**

Come off the M6 and follow the signs for Standish off the motorway roundabout. At the Standish crossroads, with Spar on the right, and Aldi on the left, turn right. Follow this road (A49) until you reach a roundabout where, from this direction, you need not give way, with 'The Cherry Gardens' pub on the left. Take the next left down Leyland Mill Lane, and on the upslope, left again down Wingates Lane, where Wigan R.U.F.C. is signposted. 500m past the houses, on the right, is an inclining track, which takes you up to the club.

### **From M61**

Come off the M61 and follow all signs for Wigan, passing through Westhoughton, and Aspull; turning left at the Aspull roundabout junction where the school is on the left. Continue all the way down to Wigan, where, when the Tesco Superstore is opposite, turn right. Follow the mini by-pass (Central Park Way) up the side of the Superstore, which is now on the left. Follow this road (A49) until you pass the hospital on the left; soon after the hospital take a right turn down Leyland Mill Lane, and on the upslope, left again down Wingates Lane, where Wigan R.U.F.C. is signposted. 500m past the houses, on the right, is an inclining track, which takes you up to the club.

08.30 am Assembly and Practice

9.30 am Start shooting

There will be no set lunch break, the Head to Head starting as soon as rankings are determined. The cut-off point will be top 16: Gents Recurve, Ladies Recurve, Gents Compound and top 4 Ladies Compound.

As laid down by FITA rules at the time of the shoot. The qualification round for all compound categories will consist of 72 arrows shot at 50 meters at a 6-ring target face. The Elimination and Finals Rounds for the compound head to head division will consist of 15 arrow matches shot in five ends of three arrows. All these matches are to be shot at 50 meters, by all compound categories at a 6-ring target

The qualification and head to head matches for all recurve categories will be shot on 122 cm faces at a distance of 70m and will continue to use the set system, but all matches (elimination and finals) will consist of a maximum of 5 sets of three arrows (winning set point score: 6 points).

All arrow holes in the target face must be marked, and all arrows must be marked, making them recognisable by the archer and conforming to FITA requirements.

For both Ladies and Gents for the Head to Head rounds there will be awards for first, second and third positions in all compound and recurve disciplines.

Entries will only be accepted from members of GNAS and FITA affiliated societies and membership cards must be produced at registration. No entries will be taken without the entry form being submitted and accompanied by the correct entry fee.

Refunds will not be made after closing date and no substitutes will be allowed.
