DIRECTIONS

Directions from North and South

Leave the M6 at Junction 29 and follow signs for the A6 to Preston. At the second set for traffic lights turn right onto Cuerden Way (Sainsburys Supermarket). The entrance for the tennis and fitness centre is behind Sainsbury's and is clearly signed posted.

From M61 and Manchester

.Leave the M61 at Junction 9 and take the M65 towards Preston. At the end of the Motorway is a roundabout with the only option to turn right towards a second large roundabout. Take the third exit taking the A6 towards Bamber Bridge, then at the first set of traffic lights turn right onto Cuerden Way (Sainsburys Supermarket).
